

## Consent to Disclosure of Tax Return Information (PreFUND)

Federal law requires this consent form be provided to you ("you" refers to each taxpayer, if more than one). Unless authorized by law, we cannot disclose, without your consent, your tax return information to third parties for purposes other than the preparation and filing of your tax return. If you consent to the disclosure of your tax return information, Federal law may not protect your tax return information from further use or distribution.

You are not required to complete this form to engage our tax return preparation services. If we obtain your signature on this form by conditioning our tax return preparation services on your consent, your consent will not be valid. If you agree to the disclosure of your tax return information, your consent is valid for the amount of time that you specify. If you do not specify the duration of your consent, your consent is valid for one year from the date of signature.

You have indicated that you are interested in applying for a loan through 1st Money Center, Inc. or 1MC Michigan LLC ("Lender"). In order to apply for a loan through Lender, we must disclose all of your 2016 tax return information to Lender.

If you would like us to disclose your 2016 tax return information to Lender for this purpose, please sign and date your consent to the disclosure of your tax return information.

By signing below, you (including each of you if there is more than one taxpayer) authorize us to disclose to Lender all of your 2016 tax return information so that Lender can process your application if you choose to apply for a loan. You understand that if you are not willing to authorize us to share your tax information with Lender, you will not be able to obtain this service from Lender.

By signing below, you (including each of you if there is more than one taxpayer) authorize Lender and its employees, agents, and contractors, via an automated system (including an automated dialing system and an automated texting system), or by any other written, electronic or telephonic means, to obtain any and all information related to debt owed by you to the United States government or to a state, or any debt enforced by a state, including child support obligations and/or any payments made or due to a federal or state agency, and to contact you regarding your loan application or account. Such debt includes debt disclosed to the Financial Management Service by the IRS in order to collect tax debt through a levy process under 26 U.S.C. § 6331(h), and to conduct tax refund offset under 26 U.S.C. § 6402. Debt information includes but is not limited to, correspondence and other information related to your debts or payments, including your tax refund payment(s).
