The tax rate for tax year 2023 is 4.4%.

 Individual Income Tax Return.
- The subtraction "Colorado ABLE Contribution" has been added to Form DR 0104AD, Subtractions from Income Schedule.
- The following credits have been added for tax year 2023:
 - o Alternative Transportation Options Credit
 - Nonrefundable Heat Pump Credit
 - Nonrefundable Residential Energy Storage Systems Credit
 - o Refundable Heat Pump Credit
 - o Refundable Residential Energy Storage Systems Credit
