Tax Law Changes

Changes to Idaho's tax law are listed in brief below. Refer to the <u>official Idaho Legislature website</u> for more information.

- Standard deductions have been updated as follows:
 - Single or Married Filing Separately \$13,850
 - Head of Household \$20,800
 - Married Filing Jointly or Qualifying Surviving Spouse \$27,700
- Idaho law conforms to the Internal Revenue Code as of January 1, 2023. Refer to 2023 ID House Bill 21 additional information.
