# **Tax Law Changes**

#### Public Act 102-0700

- The Illinois EITC has been increased to 20% of the federal EITC and expanded to taxpayers (with an ITIN) between the ages of 18 – 25 and taxpayers aged 65 or older without a qualifying child.
   This has resulted in significant changes to Schedule IL-E/EIC, Illinois Exemption and Earned Income Tax Credit, and the introduction of the Illinois Expanded EITC Worksheet.
- The K-12 Instructional Materials Credit (claimed on Schedule 1299-C, Income Tax Subtractions and Credits (for individuals)) has been increased to \$500.

#### Public Act 103-0009

- Investment partnerships are now required to withhold taxes for their nonresident partners. As a result, line 59b, "Investment partnership withholding," has been added to Forms IL-1065 and IL-1065-X, (Amended) Partnership Replacement Tax Return. Schedule K-1-P(4) has been created to aid in calculating the withholding requirement.
- The Volunteer Emergency Worker Credit has been added to line 16 of Form IL-1040, Individual Income Tax Return, and Schedule ICR, Illinois Credits.
