#### **Obsolete Schedule**

Schedule 1040C-ME has been retired for individual returns, reworked, and renamed "Composite Filing of Maine Income Tax for Nonresident Owners and Partnership Audit Return." This form is now filed at the entity level for S corporation and partnership returns.

  - Screen HCC (Health Care Coverage) Used to authorize the ME DHHS to contact taxpayers regarding free or reduced-cost health coverage plans

## **Tax Law Changes**

- An additional Property Tax Credit can now be claimed on Schedule PTFC/STFC, Property Tax Fairness
   Credit Sales Tax Fairness Credit, for a qualified taxpayer or spouse who, per the United States
   Department of Veteran Affairs, is rated 100% permanently and totally disabled. A copy of the VA Rating
   Decision Letter or VA Benefit Summary Letter is required to substantiate the additional deduction.
- A new subtraction provision allows contributions to qualified tuition programs (529 plans) for the individual and fiduciary packages. The subtraction is limited to a maximum contribution amount of \$1,000 per qualified beneficiary.
- For tax years beginning on or after January 1, 2023, but before January 1, 2024, the amount of winter energy relief payments received is deductible in calculating Maine taxable income, to the extent the payment is included in federal adjusted gross income.
- For tax years beginning on or after January 1, 2023, the cannabis business expense subtraction
  modification is extended to include expenses related to carrying on a trade or business as a
  manufacturing facility.
- For tax years beginning on or after January 1, 2023, the Passamaquoddy Tribe, the Penobscot Nation, the Houlton Band of the Maliseet Indians, and a tribal corporation organized by these tribes under section 17 of the federal Indian Reorganization Act are not subject to Maine corporate income tax.
- A new provision exempts qualified tribal earnings for enrolled members of the Houlton Band of Maliseet Indians, Passamaquoddy Tribe, and Penobscot Nation residing on tribal lands. The new Schedule ETM is to be used whether the taxpayer is entitled to a subtraction from Maine taxable income or, in some cases, an addition for net business losses.
- The maximum allowable itemized deduction on Schedule 2 (Form 1040ME), Itemized Deductions, has been increased from \$31,150  $\rightarrow$  \$33,200.
- The pension income deduction for non-military retirement benefits has been increased from \$25,000
   → \$30,000 for tax years beginning in 2023.
