Tax Law Changes

- The "Qualifying Widow(er)" filing status has been changed to "Qualifying Surviving Spouse."
- Dependent exemptions have been increased to \$4,610.
- The 2023 top marginal individual income tax rate has been reduced to 6.4%.
- The Earned Income Credit has been increased to 125% of the federal credit.
- The Two Wage Earner Credit has been increased to a maximum of \$350.
