## **Tax Law Changes**

- Code 18, "The Pediatric Cancer Research Trust Fund," has been removed from the trust fund codes
- Lines 1, 2, 3, 4, 5, and 10 have been removed from MO-A Part 3 Section A
- Lines 1, 2, 3, and 7 have been removed from MO-A Part 3 Section C
- Line 20 has been changed to "Reserved" on Form MO-1040 since the "Bring Jobs Home Deduction" has been removed
- Line 44, "Missouri Working Family Tax Credit," is the amount equal to 20% of the amount received under the federal Earned Income Tax Credit.
- The MO standard deduction amounts now match the federal standard deduction.

## **New Credits**

The following credits are new and are allowed on Form MO-TC, Miscellaneous Income Tax Credits:

- Entertainment Industry Jobs Tax Credit Any taxpayer may qualify for a tax credit for rehearsal expenses and tour expenses incurred by the taxpayer if they meet the minimum expenditure dollar amounts. The tax credit is awarded for qualifying expenses equal to 30% of a taxpayer's base investment in Missouri.
- Intern and Apprentice Recruitment Tax Credit
- Refundable Adoption Tax Credit Removes the cap from the Adoption Tax Credit program and allows the credit to be refundable.
